

# General Meeting, September 13th, 10 a.m.

We invite you to attend our September meeting, where we will discuss the proposal for the UCSC Lifelong Learners to become an Osher Lifelong Learning Institute. We'll also discuss our new interest group program and take interest group signups. Please bring your checkbook. We can't take cash.

#### **The Osher Proposal**

As you may have read in the membership renewal letter you received, UCSC Lifelong Learners has been invited by the Osher Foundation to apply for a grant with a view to becoming an endowed Osher Lifelong Learning Institute. The Bernard Osher Foundation is headquartered in San Francisco and was founded in 1977 by Bernard Osher, a successful businessman and philanthropist. The Foundation seeks to improve quality of life through support for higher education and the arts. It has funded a growing national network of lifelong learning institutes for older adults, operating on the campuses of 115 colleges and universities in the United States, and provides scholarships for university reentry students aged 25 to 50.

The purpose of this article is to outline the major features of the proposal, the potential costs and benefits for Lifelong Learners, and the process we will use to submit it to the membership for a vote.

#### What is Proposed

The Osher Foundation would give UCSC a grant of \$50,000 for our benefit in each of two years. In return, we would become an Osher Lifelong Learning Institute and undertake to increase our membership to at least 500 dues-paying members. If we succeed in that goal, Osher would then grant an endowment of \$1 million to UCSC for our benefit, the yearly income

from which would be about \$40,000. This money would be available to pay our expenses. Osher would also make a further grant of \$50,000 to bridge the period between when the endowment is made and when it starts to pay income.

Here are the things we must do to secure this backing from the Osher Foundation:

- Amend our by-laws to change our name from UCSC Lifelong Learners to the Osher Lifelong Learning Institute at UCSC.
- Amend our by-laws to add the following to our list of purposes: "To offer members non-credit educational opportunities designed for mature adults."

- 3. Increase our membership to at least 500 dues-paying members (we currently have around 350 members). We would have two years to achieve this goal. If we happen to fall short, we would not be required to return the money.
- 4. Continue and expand our existing program.

That's it. That's all we will be required to do. In all other respects, our organization will remain unchanged. Our Board of Directors, officers, interest group leaders, and other member volunteers will continue to run our organization as they have in the past. Neither the University nor the Osher Foundation will gain any control over the way we carry on our affairs, aside from the fact that we will be expected to stay within the grant budgets that we propose.

#### **Some Costs and Benefits**

What does this mean for us? For one thing, it would provide us with a measure of financial security that we do not currently enjoy. Along with most organizations today, we face increasing costs. Moreover, the

# Guest Speaker, October 18<sup>th</sup> Dr. Eleonora Pasotti Assistant Professor of Politics

Political Branding in Cities: The Decline of Machine Politics in Bogotá, Naples, and Chicago

Branding in the marketplace is ubiquitous, but the theory of its workings in politics has been slow in evolving. Dr. Pasotti draws on the experiences of three cities on three continents to show how cities suffering for decades from poor government, entrenched patronage, and social conflict made a transition to a new form of govern-

ance: brand politics. Facilitated by direct elections, low party discipline, and fiscal self-reliance, brand politics broke a vicious cycle of skepticism and inertia and opened the window for a broad set of reforms.

Dr. Pasotti has presented her research at many conferences and universities on both sides of the Atlantic. She has been a member of the UCSC faculty since 2003 and last year was visiting faculty at the European University Institute in Fiesole, Italy.

# What's New in LLL Interest Groups?

budget squeeze the University faces is forcing it to re-examine everything it does. We depend on the University for a great deal. Here, for example, are some of the things that University staff members do for us: They receive mail and process membership applications, they maintain our membership records, they answer enquiries from our members and prospective members, they hold and manage our money for us, they provide rooms for meetings, and insurance, they issue purchase orders for all the food and services we buy, and they create book award flyers and coordinate book awards.

If the University were unable to provide any of these services in the future we would have to use our membership fees to purchase them, making that money unavailable for scholarships. An Osher grant would give us the security of being able to fund these key services if it became necessary. In fact, if an application to the Osher Foundation is approved, we plan to use grant money to pay for some of these key services.

Moreover, we could use Osher grant money to pay our existing expenses, freeing up additional money for scholarships. We currently pay for our off-campus meeting rooms as well as the Stevenson College Event Center, where we hold our monthly meetings. We also pay for printing and mailing our Newsletter and postcards. We could use Osher grant money to pay those expenses. Other examples abound. Lou Rose, our treasurer last year, estimates that if we decline the Osher Foundation's offer and our membership stays at 350, after two years the money annually available for scholarships will decline from the current amount of \$12,000 to a sustainable \$8,000. He also estimates that if we accept the Foundation's offer and grow our membership to 500, the money available for scholarships will be \$26,000.

Finally, on the benefit side, we would be joining a nationwide network of over 100 similar institutions, including six of the ten UC campuses and sixteen of the twenty-three California state universities. Some institutes are new; some have been around for years. Their programs vary widely in content and delivery. As an Osher institute, we would be able to draw on their expertise for advice and ideas about developing our own programs.

Turning to the cost side of the proposal, the main downsides seem to come from the requirement that we grow to 500 plus members. Our interviews with other Osher Institutes indicate quite clearly that the Foundation does not interfere with the management of the institutes. So control is not a problem.

But growth can be a problem. Having more members will require more courses, more interest groups, and more special programs. There will be more of the problems that come with managing any organization. The general meetings will be larger, and more difficult for new members. Some of the friendly nature of our organization may be harder to maintain. It won't be as easy, or maybe even possible, for the officers and Board members to know everybody. There may be a tendency to be more bureaucratic and impersonal. We can take steps to minimize these negative consequences, of course, but we do have to admit the possibility of some effects of these kinds. We may find that interest groups become more important than ever as the places where members form close relationships and bond with Lifelong Learners.

The choice will be up to you, the members. To summarize, we believe the choice, in a nutshell, is between maintaining the friendly organization we all enjoy at the cost of diminished resources for scholarships versus accepting a larger, possibly more formal organization with greater financial security and more resources for scholarships. We should note that there has been a tendency

for Lifelong Learners to grow anyway, so perhaps we would find ourselves with 500 plus members a few years down the road, with all the challenges that would entail, whether we become an Osher institute or not.

#### **The Approval Process**

All the information we have at hand indicates that the Osher Foundation is very likely to accept our application for a grant, and the University would support us if we choose to go forward with the application. Obviously, this would be a big step for us. Our Board of Directors is considering whether to apply to become an Osher Lifelong Learning Institute as this Newsletter goes to press. If it decides to proceed, we will present the proposal to the membership at the September meeting. Then there will be time for you to study the proposal and consider the ramifications, following which there will be a vote on the proposal at the October general meeting.

Your Board is committed to doing all that we can to ensure an open and fair deliberative process. Please feel free to contact any of us with your concerns or questions.
