Treasurer's Report - Cindy Margolin

The question raised last month of why did UCSC take out \$5000 from our funds has been answered: they overpaid us \$5000 the year previous.

Courses - Lois Widom

- b) She urged we consider signing up for the new Participatory Drama Class.

Sally gave us comparative costs of for example, Peace UCC which charges \$200 per event and a 3-part event at \$150/meeting. MAH charges \$100/meeting. Barry will check on availability of rooms at UCSC on Saturday, as well as which ones are free. The other issue location of metered parking lots.
